Sealed competitive quotations are invited for **erecting Mist House 30m² (7x4.25m)** in the station.

Type of shed

Mist House using 2mm GI, B' Class pipe structure and cladding with UV stabilized polythene sheet with shade net layer inside, 7m x 4.25m (LxB) with centre height 3m and gutter height 2m;

Foundation: 30cm x30cm x75cm, concreting with 1:2:3 with crimped portion 15cm above ground level.

Specification of materials: GI pipes 2mm thick, galvanized B class, with ISI mark Clamps-32mm thick, galvanized

UV sheet for roofing: 200 micron,(Ginigar/Garware) UV stabilized 86% light transmission, anti-dust anti drip.

Shade net: 50% Green colour, Tape type – light diffusing- 90gsm.

Aluminium profile: Triple spring locking, 0.9mm thick with smooth edges. Wt.190gm/mtr.

Zig-zag wire – PVC coated spring.

The rate should be inclusive of cost of all materials, labour, unloading and transportation charges and taxes etc.

The envelope containing the quotation should be super scribed with 'Quotation for Mist House erection'to be opened at 8-3-2021 and sent to the **Professor and Head, Aromatic & Medicinal Plants Research Station, Odakkali, Pin-683549, Asamannoor P.O. 683 549, Ernakulam District, Kerala State Kerala.**

Quotations will be opened at 3.30 p.m. on the same day.

The work will be awarded to the lowest quotationer.

Quotations received late and those not conforming to specifications will not be accepted.

If quotation is accepted, the successful quotationer should execute an agreement in Kerala Stamp paper worth Rs.200/- (Rupees Two hundred only) and furnish a security deposit of 5 % of cost of the work quoted, in the form of term deposit/ bank guarantee/ demand draft drawn in favour of Professor & Head, AMPRS, Odakkali payable at SBI, Odakkali which will be returned after a period of 1 year from the date of completion. The erection of the nursery shed should be completed within 15 days of issue of work order.

The payment in full will be released immediately on satisfactory completion of the work. All other conditions applicable to purchase and of similar nature in Govt. shall be applicable in this case also.
