**NOTIFICATION**

Sub:- KAU - General Council - Shri. Harilal, nominee of the Cochin University of Science and Technology - Suspended from membership - Reg.

Whereas, Shri. Harilal, Member of the General Council representing the Cochin University of Science and Technology has used impolite, disrespectful & unparliamentary language against the Registrar & Convenor, during the proceedings of the 144<sup>th</sup> meeting of the General Council of the Kerala Agricultural University convened on 30-07-2022; and, therefore the Chairman, having the opinion that his conduct is disorderly, directed him under Rule 51 of the Statute regarding the "Powers and Functions of General Council", to withdraw immediately from the meeting; but Shri. Harilal, without respecting the rule that any member so ordered to withdraw shall do so forthwith and absent himself during the remainder of that day's meeting; remained in the meeting; and therefore the meeting was suspended for 20 minutes at 09:50 AM under Rule 52 of the Statute regarding the 'Powers and Functions of General Council';

And whereas, Shri. Harilal disrespecting the orders of the Chairman, did not withdraw from the meeting and remained in the meeting, when the meeting resumed at 10:10 AM; and he did not obey the further repeated directions of the Chairman on his withdrawal from the meeting and hence the meeting of the General Council was dissolved;

And whereas, the above disorderly conduct and unruly behaviour of Shri. Harilal in the House, and his disrespect & disobedience to the Chair amounts to serious misconduct and derogatory to the dignity of the House;

Now therefore, the Vice-Chancellor and Chairman of the General Council, in exercise of the powers conferred upon him under Rule 53 of the Statute regarding the 'Powers and Functions of General Council' ordered to impose the punishment of suspension from the membership of the General Council of the Kerala Agricultural University for a period upto and inclusive of the next two regular meetings of the General Council; on Shri. Harilal, Member of the General Council representing the Cochin University of Science and Technology.
