NCA Ranked lists thus prepared and published as per this notification shall remain in force for two years from the date of publishing the NCA Ranked lists or until candidates are advised and appointed against the vacancies earmarked for the above communities, whichever is earlier.

### Qualification

#### I. Essential

A. i) Bachelor's Degree from the concerned Faculty recognized by the Kerala Agricultural University. The clause 'concerned faculty' is not insisted in the disciplines of Agricultural Statistics, Biotechnology, Home Science and Mathematics. In the case of posts coming under Faculty of Forestry, basic degree in Forestry is insisted.

In the case of posts coming under Faculty of Agricultural Engineering - Bachelor's Degree in Agricultural Engineering recognized by Kerala Agricultural University. Provided that this shall not be insisted for those who have taken up make up courses of at least 12 credits in the semester system or 18 credits in trimester system for PG courses in Agricultural Engineering from Kerala Agricultural University.

In the case of posts coming under Veterinary and Animal Sciences, the qualification should be recognized and included in the first or second schedule to the Indian Veterinary Council Act 1984 and registered with a State Veterinary Council.

ii) Master's degree in the relevant subject recognized by the Kerala Agricultural University with a minimum 55% marks in the traditional system or their equivalent. Only the qualifying marks without including any grace mark is permissible.

The provisions contained in Sec 3.4(I), 3.5 and 3.6 of the UGC Regulations 2018 shall apply.

iii) NET conducted by ASRB/ ICAR/ UGC/ CSIR/ AICTE or similar test accredited by the UGC or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/ SLET/ SET:

Provided, the candidate registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/ Bye-laws/ Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from

the requirement of NET/ SLET/ SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/ Colleges/ Institutions subject to the fulfilment of the following conditions:

- a. The Ph.D. degree of the candidate has been awarded in a regular mode;
- b. The Ph.D. thesis has been evaluated by at least two external examiners;
- c. An open Ph.D. viva voce of the candidate has been conducted;
- d. The Candidate has published two research papers from his/her Ph.D. work, out of which atleast one is in a refereed journal;
- e. The candidate has presented at least two papers based on his/her Ph.D work in conferences/Seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Director/Dean (Academic Affairs) of the University concerned.

Note: NET/ SLET/ SET shall also not be required for such Masters Programmes in disciplines for which NET/ SLET/ SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/ SET.

OR

- B. The Ph.D. degree has been obtained from a foreign university/ institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:
  - (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

## II. Desirable

- 1. Knowledge in Malayalam language to read and write.
- 2. Ph.D. in the relevant subject recognized by the Kerala Agricultural University.

#### Nationality & Age limit

The candidate must be a citizen of India and shall not be over 50 years of age as on 01/01/2023.

#### Reservation

Reservation benefit will be allowed as per the norms of Kerala Public Service Commission on production of Community Certificate (in the case of SC/ST), 'Non-Creamy Layer certificate' (in the case of OBC), Disability certificate (in the case of differently abled) issued by the competent authority.

#### Period of Appointment

The appointment to the post of Assistant Professor shall be for a period till the incumbents attain superannuation as laid down in Section 42(4) and (5) of Kerala Agricultural University Act.

# Salary & Allowances

The scale of pay and allowances of Assistant Professor will be as per the Government orders issued in line with UGC norms.

# Application Form & Fee

No other mode of payment will be accepted. The documents uploaded online in support of the claims has to be submitted in original along with the print out of the application form at the time of verification. Application should be submitted through online mode only. Further details will be available from the Information sheet.

The mode of selection, applicable reservation, relaxation of age and all other matters relating to the appointment to the post mentioned above shall be governed by the provisions contained in the KAU Statute, UGC Regulations 2018 and orders issued by the Government from time to time.

Applications in the prescribed format are invited from eligible candidates for appointment as Assistant Professors in various departments/disciplines under the faculties of Agriculture/Agricultural Engineering/ Forestry in Kerala Agricultural University.

- i The application should be filled online from KAU Website <a href="www.kau.in">www.kau.in</a> or from the job portal <a href="http://recruit.kau.in">http://recruit.kau.in</a>
- ii If there is a difference in the name of the candidate given in the application and that given in the documents, an identity certificate from a Gazetted Officer showing that the name given in the application and in the documents are of the same person, should be produced at the time of verification of application.
- iii Candidates who are employed on regular basis in Government/Quasi Government/State Autonomous Institutions should produce No Objection Certificate.
- iv Before applying for the post, the candidate should ensure that he/she fulfills the eligibility and other norms prescribed thereto. The University reserves the right to reject any application at any stage of the recruitment process if the candidate is found ineligible for the post for which he/she applied. If appointed, such a candidate is liable to be summarily removed from the service.
