## **Essential Qualification :**

- a) A Master's Degree with 55% marks (or an equivalent grade in OGPA / point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University or an equivalent degree from an accredited foreign university.
- b) National Eligibility Test (NET) conducted by UGC, ICAR, CSIR or a similar accredited State Eligibility Test (SLET/SET) on the last date of submission of application.
- c) A candidate who has been awarded a Ph.D Degree is exempted from NET/SLET/SET.

Desirable: 1) Knowledge in Malayalam language to read and write.

#### Nationality & Age Limit:

The candidate must be a citizen of India and shall not be over 40 years age as on 01.01.2023. The age limit is relaxable in the case of SC/ST/OBC and differently abled categories as prescribed in the KS&SSR 1958 as amended from time to time.

All other conditions are as per Kerala Agricultural University norms.
