The whole matter was placed before the 133rd meeting of Academic Council held on 26.04.2019 for endorsing the ICAR declaration F.No. Edn./13/1/2016-HRD dtd. 06.10.2016 in KAU and there by ensuring that the UG degrees (4 years degree programmes) under the faculties of Agriculture, Agricultural Engineering & Forestry offered by KAU can be declared as professional degrees with retrospective effect.

After examining the matter, the Academic council has approved to endorse the ICAR declaration F.No. Edn./13/1/2016-HRD dtd. 06.10.2016 in KAU and also approved to declare that the UG degrees (4 years degree programmes) under the faculties of Agriculture, Agricultural Engineering & Forestry offered by KAU as professional degrees with retrospective effect.
