2. <u>Earnest Money Deposit</u>: An EMD of Rs.1,446/-- (Rupees One Thousand Four Hundred and Forty Six Only) should be remitted by separate DD drawn in favour of Associate Director, Regional Agricultural Research Station. Pilicode Pin-671310.

- 3. The tender should be accompanied by an Agreement in Kerala stamp paper worth Rs.200/-(Rupees Two hundred only) in the format that can be downloaded from the website www.kau.edu/tenders OR rarspil.kau.in/tenders.
- 4. The sealed cover containing the tender documents should be super scribed as "Tender for Modification of existing water tank in the form of boat"
- 5. The cover should contain the DDs for tender cost, GST, EMD and the Agreement as mentioned above.
