
TENDER NOTICE

Sealed tenders are invited for the supply of dried cowdung (Approximate 50 Ton) for farm use of the station, subject to the below stated terms and conditions.

Terms and Conditions

1. The tender form may be downloaded from the following weblink in the internet. <http://www.kau.in/tenders>. The cost of tender form is Rs 0.20% of the cost of tender (rounded to nearest 100/-, minimum Rs.400/- and a maximum of Rs.1500 + GST as applicable). Cash/ DD for the amount drawn in favour of The Professor and Head, ARS Anakkayam, payable at SBI Manjeri Town should be enclosed along with the tender submitted
2. Earnest Money Deposit (EMD) @ 1 % of the cost of items offered may be remitted by a separate cash/DD drawn as detailed above
3. The Tenderers should have to submit an agreement in Kerala Stamp Paper worth Rs. 200/- along with the tender . The form of Agreement can be downloaded from <http://www.kau.in/tenders> under the Related Document section.
4. The tender should be in the sealed cover and to reach the undersigned on or before **22.01.2026** at **2.00 pm**. Tenders received late or incomplete in any respect will be summarily rejected without notice and the decision of the undersigned on such matters will be final.
5. The tenders will be opened at 2.30 pm on the same day in the presence of those who are present at that time. The lowest rate will be accepted if reasonable.
6. Successful tenderer will have to execute an agreement on Kerala Stamp paper for Rs. 200/- and remit security deposit @ 5 % of the tender amount accepted by means of DD/cash. Form of agreement can be downloaded from the website <http://www.kau.in/tenders> under the Related Document section.
7. The sealed cover containing the tender documents should be superscribed with "**Supply of dried cowdung**" and sent to the Professor & Head, ARS ANAKKAYAM, 676509.
8. The supply has to be done in a period of 7 days from date of placement of order
9. The rate quoted should be inclusive of cost of items (with tax),Transportation and Labour charges if any.

10. The rate will be valid for 1 year from the date of confirmation of tender. The payment will be through invoice/credit bill system and by cheque/transfer.
11. Income Tax in the eligible rate will be recovered from the final payment .
12. The decision of the Professor and Head, ARS Anakkayam will be final and abiding.
13. The undersigned reserves the authority to accept or reject any or all the tenders without assigning any reason
