The tender fee. is Rs.0.2% of the quoted amount {(rounded to nearest 100/- subject to minimum Rs.400/- and maximum of Rs.1500) + 18 % GST}. Two separate demand drafts for tender fee and GST drawn in favour of Dean, CoA, Padannakkad payable at Nileshwar should be enclosed along with the tender submitted.
- 2. Earnest Money Deposit (EMD) of Rs.1500 may be remitted by a separate DD drawn in favour of Dean, CoA, Padannakkad as detailed above.
- 3. Agreement on Kerala Stamp paper for Rs. 200/- (Form of agreement can be downloaded from the website www.kau.in/tenders) should also be enclosed.
- 4. Tenders received late or incomplete in any respect will be summarily rejected without notice and the decision of the undersigned on such matters will be final.
- 5. Successful tenderers will have to execute an agreement in stamp paper worth Rs.200/-and remit security deposit @ 5% of the total amount quoted, in the form of DD or fixed deposit receipt. The format of the agreement can be downloaded from the above website.
- 6. The sealed cover containing the tender documents should be super scribed "Tender for the repair and service of GCMS machine" and sent to The Dean, College of Agriculture, Padannakkad.
- 7. The repair work has to be done within one week from date of receipt of work order.
- 8. The rate quoted should be inclusive of all taxes, duties, charges and cost of spare parts, if any. The transportation cost, loading and unloading charges etc., should be borne by the firm.
- 9. Bidder should have past experiences in repair and service of the equipment in various Government institutions/firms. Relevant documents for proof should be attached with the tender.
- 10. The payment will be made through invoice/credit bill system by the bank transfer.
- 11. Photo copy of PAN card and GST registration should be enclosed with the tender.
- 12. Income tax at the eligible rate will be recovered from the bill at the time of payment.
- 13. The equipment can be inspected during office hours before preparing the quotation.
