Sealed tenders are invited for the for the supply and cutting works of PVC foam board 2.44 m x 1.22 m x 17 mm for rapid multiplication of black pepper as specification mentioned below and subject to the conditions stipulated hereunder.

The cost of Tender form is Rs.0.2% of the quoted amount {(rounded to nearest 100/- subject to minimum Rs.400/- and maximum of ₹1500) + 18 % GST}. A DD for the amount drawn in favour of Assistant Professor and Head, Pepper Research Station, Panniyur, payable at SBI Poovam should be enclosed along with the tender submitted.
2. Earnest Money Deposit (EMD) @ 1% of the cost of items (subject to minimum of ₹1500) offered may be remitted by a separate DD drawn as detailed above.
3. Agreement on Kerala Stamp paper for ₹200/- (Form of agreement can be downloaded from the website www.kau.in/tenders under the Related Documents section.)
4. Tenders received late or incomplete in any respect will be summarily rejected without notice and the decision of the undersigned on such matters will be final.
5. Successful tenderers will have to execute an agreement in stamp paper worth ₹200/- and remit security deposit @ 5% of the cost of the items quoted in the form of DD or fixed deposit receipt. The format of the agreement can be downloaded from the above website.
6. The sealed cover containing the tender documents should be superscribed "supply and cutting works of PVC foam board 2.44 m x 1.22 m x 17 mm for rapid multiplication of black pepper" and sent to The Asst. Professor and Head, Pepper Research Station, Panniyur, Kanhirangad (PO), Taliparamba, Pin-670142.
7. The supply has to be made in a period of one week from date of placement of order. The lowest tender will be identified based on the lowest cumulative total of all the items taken together for the above said quantity.
8. The rate quoted should be inclusive of all charges including GST if any and also connected expenses if any. The transportation cost also should be included in the rate.

9. The rate will be valid for the financial year 2025-26. The payment will be through invoice/credit bill system.
10. The tender should be in the sealed cover to reach the undersigned on or before 24.10.2025 at 2.00 pm. Late tenders will be rejected.
11. The tenders will be opened at 2.30 pm on the same day in the presence of those who are present at that time. The lowest rate will be accepted if reasonable.
12. The decision of the Assistant Professor & Head, Panniyur will be final and abiding.
