- The cost of tender form. GST and EMD will be accepted by way of separate DDs in favour of Associate Director, Regional Agricultural Research Station. Ambalavayal, Pin - 673593
- Earnest Money Deposit:** An EMD(1% of the amount quoted) should be remitted by separate DD drawn in favour of Associate Director, Regional Agricultural Research Station. Ambalavayal Pin - 673593, by cash and online transfer.
- The tender should be accompanied by an agreement in Kerala stamp paper worth Rs. 200/- (Rupees Two hundred only) in the format that can be downloaded from the website www.kau.in/tenders
- The sealed cover containing the tender documents should be super scribed as "Tender for **supply of Fertilizers and PP Chemicals**" at COE, Ambalavayal". The cover should contain the DDs for tender cost, EMD and the Agreement as mentioned above.
- The successful tenders should execute and agreement in Kerala Stamp paper worth Rs. 200/- (Rupees Two hundred only) and furnish a security deposit of 5% of cost of the rate quoted in the form of term deposit/bank guarantee/demand draft drawn in favour of Associate Director, Regional Agricultural Research Station. Ambalavayal Pin - 673593, Wayanad District payable at the State Bank of India, Kolagappara (IFSC: SBIN0070615), When directed from this office.
- The rate quoted, tax and other charges if any should be separately stated.
- The Associate Director has the right to accept or reject any or all of the offers without assigning any reason.
- The successful Tender shall initiate the supply the item within one week of award as per demand.
- If any hartal/strike/any unexpected holiday occurs on the date of opening of tender, the tender will be opened at the same time on the next working day
- All the rules and regulation applicable to government tender will be applicable to this tender also.
- All the items must be delivered (including unloading) at the storage house of Center of Excellence for Vegetables and Flowers, Wayanad.

Special Conditions:

- The agency must have a valid pesticide and fertilizer license issued by the State Agriculture Department.
- They must supply authentic products from registered manufacturers.
- The lime must meet the required quality standards and have a Neutralizing Value (NV) of 135 or above, as per the Fertilizer (Control) Order, 1985. The material should be free from impurities and suitable for agricultural use. The supplier must provide a Certificate of Analysis (COA) confirming the specified Neutralizing Value. Field

- Pesticides must comply with Insecticides Act, 1968, and the Central Insecticides Board & Registration Committee (CIBRC) guidelines.
- Fertilizers must adhere to Fertilizer (Control) Order, 1985, specifying nutrient content and permissible limits for impurities.
- Dealers quoting the same product from multiple companies must clearly specify the product name, company name (manufacturer), and the quoted rate for each.
- The pesticides must have a minimum remaining shelf life of 1.5 years at the time of delivery.
