2. The sealed cover containing the tender document should be superscribed as "Tender for supply of "Digital SLR camera and Lens " and send to the **Director, Centre for e-Learning, IT-BT Complex, Main Campus, Kerala Agricultural University, KAU, P.O., Thrissur, PIN - 680656 Kerala.**
3. The tender should be accompanied by agreement in Kerala stamp paper worth Rs. 200/- .and format of agreement can be downloaded from the website <http://www.kau.edu/tenders> under the related document section. Withdrawal of tenders after its acceptance or failure to supply the product or supply not according to the specifications will entail cancellation of the tender.
