TENDER NOTICE

Sealed tenders are invited from authorized dealers/suppliers for the supply and installation of 10 (Ten) maintenance-free 12V, 150 AH batteries with a buy-back arrangement for the old batteries currently installed at the Plant Pathology Department of this station, as per the following terms and conditions.

Scope of Work

- Supply and installation of 10 maintenance-free batteries with specifications: 12V, 150
- The batteries should be compatible with a 5KV UPS.
- The supplier shall replace the old 10 number 12V, 150 AH batteries on a buy-back basis

Place of Supply

 The supply and installation shall take place at the Plant Pathology Department, Regional Agricultural Research Station, Pattambi Under Kerala Agricultural University.

Eligibility Criteria

The supplier must be a an authorized dealer of a reputed brand or a manufacturer with proven experience in supplying and installing UPS batteries of similar capacity.

Warranty

A warranty of minimum 3 years from the date of installation should be provided for the new batteries.

Other Conditions:

- The batteries must be maintenance-free and come with a minimum warranty of 3 years.
- The supplier must provide a detailed datasheet or technical brochure of the offered
- The bidder must quote the buy-back value for the old batteries separately, which will be deducted from the total cost of the new batteries
- The supplier must ensure the safe removal of the old batteries and proper installation of the new ones.
- Installation and Testing: The supplier shall ensure that the batteries are installed, tested, and functioning properly with the existing 5KV UPS system.

Terms and condition:-

- Tender should be submitted in the prescribed form which can be downloaded from the
 web link www.rarsptb.kau.in/tenders, https://kau.in/tenders. The cost of tender form is
 Rs. 400/- + 18% GST (ie. Total amount of Rs. 472/-) which will be accepted by way of
 Demand Draft drawn in favour of "Associate Director of Research, Regional Agricultural
 Research Station, Pattambi "payable at State Bank of India, Pattambi and should be send
 separately along with the tender
- 2. The tender should be accompanied by an agreement in Kerala stamp paper worth Rs. 200/- (Rupees Two Hundred only), the format of which can be downloaded from the above website. Withdrawal of tenders after its acceptance or failure to supply the items or not according to the specification will entail cancellation of tender.
- EMD amount of Rs. 2000/- should be remitted along with the tender cost of Rs. 472/- by
 two separate Demand Drafts drawn in favour of Associate Director of Research, Regional
 Agricultural Research Station, Pattambi payable at State Bank of India, Pattambi. No
 other Demand Draft will be entertained.
- The sealed cover containing the tender should be super scribed as "Tender for Supply and Installation of 12V, 150 AH Batteries with Buy-back", as per tender notice No. D3-5223/2024 dtd .10.2024.
 - 5. Tenders will be accepted up to 2 pm on 28.10.2024. Tenders received after the stipulated time will not be accepted.
 - Tenders will be opened at 2.30 pm on the same day at the presence of bidders/ their representatives who are present at that time.
- 7. The bidder of the accepted tender should enter into an agreement with the Associate Director of Research, Regional Agricultural Research Station, Pattambi on Kerala stamp paper worth Rs. 200/-. The format of the agreement is available in the web link www.rarsptb.kau.in/tenders. He should also submit a security deposit equal to 5% of the cost of above mentioned items in the form of Term Deposit/Bank Guarantee/Demand Draft drawn in favour of Associate Director of Research, Pattambi, payable at State Bank of India, Pattambi.
- 8. Rate and warranty/ guarantee of the item should be quoted separately.
- The item should be supplied in accordance with the supply order issued from this office and installed accordingly.
- Payment will be made only after the successful supply, installation, and testing of the batteries.
- Any failure on the part of supplier in the fulfillment of contractual obligations will result in the forfeiture of EMD/Security Deposit.
- 12. All other technical and commercial terms and conditions as per the code rules in force in Kerala State will be applicable in this case also.

Special Conditions.

1. Tenders insisting payment in advance either full or in part for releasing the documents through bank are liable to be rejected.

2. The undersigned reserves the authority to accept or reject any or all of the offers for the above mentioned items without assigning any reason whatsoever.

3. The decision of the undersigned in finalizing the tenders shall be final and binding.
