Sealed tenders are invited for the supply of PCR machine with accessories to the DST SERB project entitled "Faunal diversity of spider mites (Prostigmata: Tetranychidae) associated with agricultural ecosystems of Kerala" under AINP on Agricultural Acarology, Department of Agricultural Entomology, CoH, Vellanikkara. - 4. The offer for the item should indicate separately the basic unit, accessories and optional, and its cost. Taxes, customs and excise duty, packing, forwarding, insurance and any other cost for its installation, if any, should also be included.
- The sealed cover containing the tender documents should be superscribed "Tender for supply of PCR machine" andsent to TheProfessor and Head, Department of Agricultural Entomology, College of Horticulture, Vellanikkara, KAU (P.O) Thrissur, Kerala - 680 656.
